- (1) By signing this Series Entry Form, each Competitor and Driver acknowledges that all Meetings (whether or not part of a Series) will be held under the International Sporting Code (ISC) of the FIA; the provisions of the 2014 Karting Manual of the Australian Karting Association Limited trading as Karting Australia (KA), the Sporting and Technical Regulations of the CIK Stars of Karting Series, the Supplementary Regulations, any Further Regulations or instructions and any Bulletins that may be issued by KA (collectively referred to as the Rules), and that the Competitor and Driver/s agree to be bound by these Rules.
- (2) This Series Entry Form must be read in conjunction with the Rules of which it forms a part.
- (3) The completion by a Competitor and Driver/s, and submission to KA of this Series Entry Form will be confirmation by such Competitor of an Entry to a Meeting in accordance with the provisions of the ISC and the Rules.
- (4) Individual Meeting Opening and Closing of Entry dates are indicated in the Supplementary Regulations for that Meeting. Any Competitor or Driver who chooses not to accept the Rules and conditions of a Meeting as detailed in the relevant Supplementary Regulations for that Meeting may withdraw their Entry by advising AKA in writing prior to the time indicated in the Supplementary Regulations for the closing of Entries for that Meeting.
- (5) The dates and venues listed in this Series Entry Form are subject to change as approved by KA.
- (6) It is the responsibility of the Competitor to ensure that all details on this Series Entry Form are correct prior to the commencement of competition at a Meeting.

For Competitors:

I/We being the Competitor of the Kart described on this Series Entry Form wish to enter that Kart for the above event/s, and declare that the Kart and all related equipment and components necessary for competition shall be presented, at all times and in every respect, in compliance with KA Rules and Appendices and Schedules thereto, and to the event, sporting and technical regulations pertaining to the competition/s for which I have entered.

I further declare that I have caused the Kart to be inspected according to a maintenance schedule that I have developed, and that it is free from mechanical defects or structural integrity that may render the Kart unsafe for competition.

I acknowledge that where any aspect of the Kart or related equipment and components is found:

- to be in breach of the Rules and/or the Rules of the event, or;
- in the opinion of the Chief Scrutineer, to be subject to a serious mechanical defect,

it will render me in breach of the Rules, and that I may be subject to penalties in accordance with the Rules.

My signature below indicates my acceptance of the above.

For Competitor and Driver/s:

I/We being the competitor and/or driver/s identified on this Series Entry Form, certify that the particulars on this form are true and correct in every particular, to the best of my/our knowledge and belief, and that we will notify the Championship Coordinator if the details change at any time.

I/We declare that I/We have read and understood the Rules issued for the event, and agree to be bound by them and the provisions of the Rules of KA.

I/We agree that should I/We choose not to accept the conditions of Entry to a Meeting as indicated in the Supplementary Regulations for that Meeting, that I/we will advising the Championship Coordinator in writing prior to the time indicated in the Supplementary Regulations for the closing of entries for that Meeting of such non acceptance.

In exchange for being able to attend or participate in the event/s (including entering the event/s), I agree;

 - **the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure the safety of persons or property at the event/s.**

I have had sufficient opportunity to read this declaration (including the releases, waivers, assumptions of risk and indemnities contained herein) and that I fully understand its terms. I understand that I will give up substantial rights by signing it and I sign it freely and voluntarily, without inducement of any kind. I understand my signature to this document constitutes a complete and unconditional release of all liability of the Associated Entities to the greatest extent allowed by law in the event of me and/or the children under my care suffering harm.
